



# PLAYER'S LICENSING

The player's licensing process applies to both Ordinary Members and Associate Club Members.

Once registration is complete and the proper forms have been signed and submitted to BAS, the player becomes an official member of the club. As a licensed member, the player is then eligible to participate in BAS competitions, representing his club.

Players can only register for a license through their club. The club at which the player is first registered will hold the player's registration rights until it is transferred to another club.

## 1. Rights of Licensed Players

- 1.1. This license allows the player to play for the club in competitions.
- 1.2. At their first registration, each player will be given a unique player's license number and this number will follow the player for his lifetime.

## 2. Player's Licensing Fee

- 2.1. The licensing fee for each player shall be:
  - 2.1.1. Singapore Citizen – SGD 30
  - 2.1.2. Non-Citizen – SGD 60
- 2.2. This is a one-time payment and the license will be valid for the player's lifetime, unless otherwise revoked by BAS.
- 2.3. For the avoidance of doubt, any player not holding a Singapore passport at the time of registration shall be classified as a non-citizen.
- 2.4. The one-time licensing fee shall be payable during the application. All fees paid shall be non-refundable.

## 3. Renewal of Registration Rights

- 3.1. The club of the player's initial licensing will hold the player's registration rights for a period of 2 calendar years (ending 31 December).
- 3.2. Clubs can renew their registration rights of their players at any time for another 2 calendar years (ending 31 December), provided the following are submitted to BAS office:
  - 3.2.1. Completed player's registration renewal form
  - 3.2.2. Renewal fee of \$20 per player
- 3.3. Clubs that did not renew the registration rights to any of their registered players by the expiry of the player's registration cycle will be deemed to have lost the rights to the player's registration. The player's registration rights are then free to be renewed by other clubs, provided the necessary forms are submitted and renewal fee paid.

## 4. Submission Process

- 4.1. The club must submit the following to BAS during the initial registration for a player's license:
  - 4.1.1. A copy of the player's passport (identification number hidden)
  - 4.1.2. Completed and signed player license application form
  - 4.1.3. Payment of player's licensing fee

## 5. Sanctioned Players

- 5.1. In the event that BAS has imposed a sanction on a player, and as long as the sanction is in place, the said player cannot be registered with any club other than the one with which he is registered at the time the ban is imposed.



## PLAYER'S LICENSING

- 5.2. In the event that BAS has imposed a sanction on a club, and as long as the sanction is in place, the said club can only renew players who were licensed with the club at the time the ban was imposed.
- 5.3. The club is at all times strictly liable for the eligibility of all players registered. Upon discovery that a player was not properly registered, BAS will initiate an inquiry to establish such person's eligibility and possible disciplinary consequences. During the inquiry, the said player will not be allowed to participate in any competition.
- 5.4. All licenses held by the player become automatically null and void when the license is revoked by BAS.
