Objective

To advance the development of the game of Basketball and enhance the standard thereof.

To assist the Singapore National Olympic Council and Singapore Sports Council or other organisations in the promotion of the game of Basketball.

To promote and arrange basketball competition, for the benefit of affiliated clubs, associations and teams desiring to visit Singapore.

Vision

To develop basketball as the team sport of choice in terms of participation, public interest and sports excellence

Mission

To increase participation at all levels

To develop the game to a competitive elite sport

To rejuvenate interests and contribute to the pride and economy of our nation

Term Limit of Board

The term of office of Elected Board members shall be three (3) years. However, at the first election following the adoption of the BAS Constitution, five (5) of the Elected Board Members will be elected for a three (3) year term and four (4) of the Elected Board Members with the lowest votes will be elected for a two (2) year term of office to allow for staggered terms of office for Elected Board Members.

The term of office of Appointed Board Members shall be up to two (2) years.

Counting from the year 2019, Board Members may serve a maximum tenure of eight (8) consecutive years on the Board and, upon reaching this tenure limit, shall only be eligible for re-election or re-appointment to the Board after a lapse of at least two (2) years.

A Board Member may only hold the appointment of Treasurer for a maximum of four (4) consecutive years and may only be considered for re-appointment as a Treasurer after a lapse of at least two (2) years.

The Association is not subject to externally imposed capital requirements.

The building fund was set up for the Association's leasehold improvements. This is amortised according to the useful life of leasehold improvements. During the year, the amortisation of the building fund amounted to S\$Nil (2021: S\$15,956).

Staffing

The Secretariat of Basketball Association of Singapore is headed by Mr James Soh Poh Leong, the Chief Executive Officer, who was appointed on 25 March 2022.

As at 31 March 2023, there were 5 full time and 2 part time staff.

Employee Remuneration

There is only one employee whose annual remuneration (including employer CPF) for 2022/2023 fall in this category (from \$100,000 - \$150,000).

There is no paid staff related to Chief Executive Officer and Management Committee, who each receives total remuneration of more than \$50,000 during the year.

Conflict of Interest Policy

Board members shall act in the best interests of BAS, and the Board shall set clear policies, procedures and take appropriate measures to declare, prevent and address any conflict of interest that may arise. Whenever a member of the Board is in any way, directly or indirectly, has an interest in a transaction or project or other matter to be discussed at a meeting, the member shall disclose the nature of his interest before the discussion on the matter begins. The Board Member concerned shall then offer to withdraw and leave the meeting and not participate in the discussion or vote on the matter. The Board shall decide if this should be accepted.

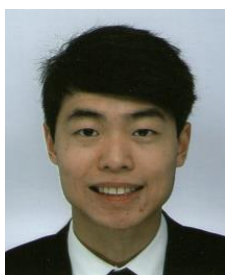

President's Statement for AGM, 14 Sept 2023

As we gather, it marks two years since the current Management Committee (MC) assumed office in 2021. I would like to express my deepest gratitude and appreciation to each member of the MC for their dedicated efforts, which have been instrumental in helping BAS achieve many of our objectives.

Throughout the years, we have continued our relentless effort in promoting basketball as a sport of choice amongst the community, especially in the challenging times after the COVID-19 pandemic. I am delighted to see every sub-committee investing significant time and effort in organizing events that cater to the diverse needs of various stakeholders within the Singaporean basketball community.

I would like to express my heartfelt gratitude to our esteemed sporting partners - Singapore National Olympic Council, Sport Singapore, Li Ning (Sunlight Sports Pte Ltd), Molten (Pacific Sports Pte Ltd), Bona Far East & Pacific Pte Ltd, Sports Physiotherapy Orthopedic Rehabilitation Training Pte Ltd, Noble Wealth Group, and Rigorer Singapore - for their unwavering support. Your continuous support is highly valued, and I am eagerly looking forward to fostering further collaborations with all our partners to promote basketball.

Annual General Meeting 2022

The Annual General Meeting (AGM) took place on September 18, 2022, during which the implementation of the amended BAS Constitution was put to a vote. The proposed changes were approved, and it was agreed to enact the amended BAS Constitution 2021 (except the AGM-election provisions) from 1st October 2022. The remaining AGM-election provision will come into effect on 1st April 2023. This implementation aligns with the requirements of Sports Singapore and fulfills one of BAS's key deliverables. I thank the members who were present and approved its implementation from October 2022 onwards

National Teams, 31th SEA Games 2021 and FIBA 3x3 Asia Cup 2022 / 2023

The 31st SEA Games held in Hanoi, Vietnam, from May 12 to 23, 2022, witnessed the active participation of both our Senior Men's and Women's National Teams. Notably, BAS achieved a historic milestone by sending four teams, competing in both the 3x3 and 5v5 categories, marking the first time ever. Although the teams did not secure podium finishes, the experience gained and exposure received during the games were invaluable for their future competitions. The teams also garnered significant media attention, including media interviews in the lead-up to the SEA Games.

The 5v5 and 3x3 as well as the Youth National Teams participated in multiple qualifiers and tournaments, excelling in their performances. The athletes acquired valuable competition

exposure and experience that will serve as a solid foundation for their future endeavours in upcoming competitions.

The prestigious FIBA 3x3 Asia Cup witnessed its FIFTH edition in Singapore from July 6-10, 2022, followed by the SIXTH edition from March 29 to April 2, 2023. Our BAS Men's and Women's teams participated in both events, demonstrating remarkable determination and effort as they competed against formidable opponents on the international stage.

Notably, our 3x3 Men's Team achieved a significant milestone by securing a spot in the Quarter-finals. Despite facing a tough battle against Team China, the team displayed exceptional performance and competitive spirit throughout the match. The participation of BAS in these editions of the FIBA 3x3 Asia Cup showcased our commitment to excellence in the sport, and the impressive showing of our athletes bodes well for future international competitions

I extend my heartfelt gratitude to SportSG and SNOC for their unwavering trust and support in basketball. BAS, in collaboration with the Coaching & Development Committee, is committed to working closely on the High-Performance Competition Plan, as we meticulously prepare for future international competitions

Major Domestic Tournaments

In early April 2022, as COVID-19 restrictions eased, BAS made a successful return to action by hosting the BAS 3x3 Open 2022 tournament. The tournament saw the participation of 41 teams and a total of 164 individuals. Adding to the significance of the occasion, Mr. Eric Chua, Parliamentary Secretary from the Ministry of Culture, Community and Youth, and the Ministry of Social and Family Development, graced the event as our Guest of Honour. He graciously presented the prizes, trophies, and medals to the deserving winning teams.

During June 2022, BAS hosted the Rigoer Youth Championship 2022, formerly known as the Milo Cup, which saw a record-breaking participation of 82 teams. This year, we introduced live streaming of the Finals, attracting an impressive viewership of over 11,371 for the 8 games streamed live.

Between August to September 2022, we witnessed the revival of the National Basketball League, featuring ten (10) of Singapore's prestigious teams and elite athletes. They competed fiercely in 45 matches during the preliminary rounds at the Singapore Basketball Centre. The excitement continued with six thrilling semi-finals and finals matches held at the Toa Payoh Sports Hall. To ensure broader access, all games were live-streamed on our social platform, attracting an impressive viewership of over 94,000. We were honoured to have Mr. Eric Chua, Senior Parliamentary Secretary for the Ministry of Culture, Community and Youth, and the Ministry of Social and Family Development, join us as the Guest of Honor. He graced the event and presented the prizes, trophies, and medals to the deserving winning teams.

Between October and November 2022, the Women's National Basketball Leagues witnessed the active participation of fourteen (14) teams. A total of 53 matches were played, with some hosted at the Singapore Basketball Centre and the Semi-finals and finals held at

the Toa Payoh Sports Hall. In the same vein, BAS live-streamed all the games on our social platform, garnering an impressive viewership of over 38,000. We were privileged to have Dr. Teoh Chin Sim, Chair of the Women in Sport Committee of the Singapore National Olympic Council (SNOC), as our esteemed guest and presented the prizes, trophies, and medals to the well-deserving winning teams.

During March 2023, the Southeast Asia Women Basketball League (SWBL) was held at the Toa Payoh Sports Hall from the 3rd to the 5th. The event brought together three neighbouring countries, namely Indonesia, Malaysia, and Thailand, who came to Singapore to prepare together for the SEA Games 2023, Cambodia. We were honoured to have the presence of Ms. Josephine Teo, Minister for Communications and Information, and Second Minister for Home Affairs, who graciously graced the occasion.

Coaching & Development

In both May and October 2022, the Coaching & Development (C&D) Committee successfully organized and conducted two SG-Coach Level One Basketball Coaching Courses. These courses saw a total of 56 participants attending, and the committee ensured the smooth completion of the courses without compromising their high standards and quality.

During the period spanning April 2022 to March 2023, the Coaching and Development team successfully organized several coaching clinics in partnership with various collaborators. One notable clinic was the Sports Performance Specialist Level 1 course, a significant joint effort between BAS and FIBA Asia. The main goal of this course was to enrich the basketball ecosystem by offering participants a specialized strength and conditioning program tailored to basketball. Moving forward, the C&D team remains committed to organizing further coaching clinics that cater to the needs of our participants.

Technical Committee

In light of the relaxation of COVID-19 restrictions, the Fiscal Year 2022 has emerged as a notably active period for technical officials. They are presented with diverse opportunities for deployment across a range of games and events. In addition to these deployments, the technical committees of the Basketball Association of Singapore (BAS) have been diligently coordinating initiatives to enhance the proficiency of referees at fundamental levels. These efforts entail close collaboration with FIBA on essential endeavors like Referee Clinics and 3x3 Licensing.

It's noteworthy that FIBA, recognizing the capabilities of the Basketball Association of Singapore (BAS), has generously allocated six (6) slots for FIBA Referees and three (3) slots for FIBA Commissioners as part of the FIBA GOL 2023-2025 program.

We take immense pride in the fact that Singapore's FIBA Referees have received nominations for assignments beyond the geographical confines of South East Asia and the Asian continent.

Sponsorships and Digital Media Presence

The Marketing and Publicity (M&P) division remains steadfast in its pursuit of primary objectives, which involve adopting a proactive stance to amplify digital involvement in basketball. Simultaneously, the division aims to bolster the Association's visibility among the public and augment the digital attention directed towards basketball.

The M&P consistently generates high-quality content, serving as a means to engage the basketball community and entice a larger following for the sport. Emphasizing the utilization of social media platforms and cutting-edge websites stands as a pivotal approach employed by the Basketball Association of Singapore (BAS) to establish connections with the public and basketball enthusiasts.

The M&P is perpetually engaged in refining its branding efforts and actively shaping a commercial strategy in alignment with the objective of expanding and diversifying revenue streams. These endeavors are undertaken with the overarching aim of enhancing self-sustainability.

SAFE SPORTS PROGRAMME

In our capacity as the National Sports Association (NSA) overseeing basketball in Singapore, the Basketball Association of Singapore is resolute in its commitment to fostering a secure environment within the realm of basketball. We are dedicated to shielding our athletes from any form of abuse or harassment that could compromise both their physical and mental well-being, as well as the integrity of the sport itself.

Cultivating a positive sporting culture is a collective responsibility. In the year 2020, during a period of halted sports competitions, a number of athletes courageously came forward to shed light on instances of mistreatment they had encountered and endured. Their calls for an end to such practices were not only heard but acknowledged. At BAS, we are unwavering in our efforts to establish a harmonized and well-coordinated safeguarding framework throughout the basketball ecosystem, encompassing organizations responsible for orchestrating, managing, and facilitating basketball participation.

As of January 2023, BAS has aligned itself with The Safe Sport Commission Singapore as a committed participant in 'The Safe Sport Programme'. This program encompasses all the essential components required to effectively implement the Unified Code within sporting organizations. This involvement entails receiving assistance and support in various crucial domains:

- Policymaking
- Training and Education
- Facilitating Support
- Case Management Service
- Access to Systems
- Accreditation

Marketing and Publicity launched the new logo to signal the importance of basketball for both genders.</p> <p>Dr Koh thanked the ordinary members (OMs) and Management Committee (MC) members for their support and attendance and envisioned the community’s unity and bringing basketball to a new height.</p> <p>Dr Koh thanked Sport Singapore for their guidance, support, and funding, as well as secretariat staff for their hard work.</p>

Unable to appoint replacement auditor within short notice periods and with other audit firm facing similar constraints. iv. Auditors were not in favour in appointing subcontractors due to audit quality concern.

President Dr Koh explained and emphasized to attendees that finance reports were presented by Honorary Treasurer to MC members and that MC members could address the finance report if they had any concerns or issues.</p>

7.3	<p><u>Letter 2 – from Mr Ong Peng Kiat (Kim Huat R&E Basketball Club)</u></p> <p>General Manager, James Soh, read out the letter to attendees.</p> <p>In response to Mr Ong Peng Kiat's letter, General Manager (GM) James Soh read out the written letter sent by SportSG—Dr Su Chun Wei, Chief Singapore Institute dated 25 May 2022.</p>

It has come to SportSG’s attention that the Basketball Association of Singapore (BAS) did not manage to pass the resolution to implement the amended BAS Constitution 2021 (except the Annual General Meeting (AGM)-election provisions) to Q2 of Year 2022 at the recent Extraordinary General Meeting (EOGM) that was held on 17 April 2022. 2. SportSG is disappointed with the outcome. 3. According to the roadmap that BAS submitted on 31 August 2021 (as part of the agreement to reinstate BAS fundings), BAS had committed to endorse the implementation of the amended constitution at the EOGM in April 2022, and to hold the Annual General Meeting (AGM) based on the amended constitution in June 2022. This commitment was not met. 4. I urge BAS to pass the resolution of implementing the amended BAS Constitution 2021 (except the AGM-election provisions) at the upcoming AGM on 26 June 2022. 5. I reiterate that the implementation of the amended constitution is for the purpose of proper and good governance, and the continued funding to BAS by SportSG is dependent on this shared alignment. <p>In response to Mr Ong Peng Kiat’s second question, Legal Advisor Mr Cory Wong referred to page 19 of Basketball Association of Singapore Annual Report 2021/2022, Minutes of Annual General Meeting 2021, 30 May 2021, 11am. As written and explained, Legal Advisor Mr Cory Wong informed members that as the constitution Rule 7.2 states that “every nomination must be seconded by another BAS member”. This means that all that is required for a valid nomination is just one other BAS member to second or propose. The BAS nomination forms call for both a proposer and seconder just so as to be on the safe side. But these two affected club’s nominations remain valid because they still have valid support from one other BAS member. It is not necessary to have two signatories according to the clear language of Rule 7.2.</p>
7.4	<p><u>Letter 3 – from Mr Chan Say Gay (Adriot Sports Association)</u></p> <p>General Manager, James Soh, read out the letter to attendees.</p> <p>In response to Mr. Chan Say Gay's letter, Dr. Koh Koon Teck stated that the Honorary Treasurer had previously responded to the question listed during the reporting of the Annual Statement of Accounts for the Fiscal Year ended March 31, 2022.</p> <p>Addressing other questions, Dr Koh Koon Teck shared with members, with the acknowledgement of MC members, that there were two (2) workshops held with SportSg with the intention to assist NSAs in being self-reliant and with the gap observed for BAS to generate revenue. A follow-up recommendation by FIBA Singapore, with support from SportSG, identified Australia as one of the countries with a successful model. The study trip was postponed to August, away from its initial proposed date in June, so there will be a proper</p>

	<p>assessment of the staff assigned and the business model run by full-time staff.</p> <p>Dr Koh Koon Teck shared that constitution did not indicate any specifications or guidelines with regards to the staff, while under probation, to be sent for training or oversea trip, and the recommendation was made by FIBA Singapore and SportSG, in support of the President.</p> <p>GM James Soh shared with attendees the approving authority and approving limit for the purchase of goods and services. GM has been authorized to approve an expense of up to \$1,000 and the President has been authorized to approve an expense of up to \$10,000. For the requisition above, the mentioned amount must be presented to the EXCO committee for up to \$20,000 and to the MC for \$20,000 and above.</p> <p>Further to Mr Koh Kah Tiong's inquiries about the study trip, Legal Advisor Cory Wong sought to clarify with Mr Koh Kah Tiong his definition and perspective of damage done or wrongdoing for sending staff on probation for a study trip. In response, Mr. Koh Kah Tiong stated that there should be proper governance by any organization and that it is wrong to send probation staff on a study trip. Mr Cory Wong stated that there are numerous methods for employees to instate into their employment contract and there is nothing wrong with implementing the procedure.</p> <p>Mr Koh Kah Tiong wished to put on record that statement based on the statement made by Legal advisor Cory Wong.</p> <p>Mr Chan Say Gay (representative of Adroit Sports Association) further stated he wanted an answer if it was a right practice made by BAS but did not make any specific statement indicating if it was right or wrong.</p>

3. National Teams Progression and Development

31st SEA Games, Hanoi, Vietnam

The 31st edition of the SEA Games, hosted in Hanoi, Vietnam, spanning from May 12 to 23, 2022, observed dynamic engagement from our Senior Men's and Women's National Teams in both 5v5 and 3x3 categories. While podium placements eluded the teams on this occasion, the knowledge acquired and the visibility garnered during the event hold immeasurable value for their forthcoming endeavours.

FIBA TOURNAMENT

FIBA Asia 2025 Pre Qualifiers

Our Men's 5v5 team participated in the FIBA-Asia 2025 Pre-Qualifiers, with the first round occurring from November 9 to 12, 2022, in Bangalore, India. Subsequently, they successfully advanced to the second round held in Ulaanbaatar, Mongolia, from February 24 to 26 2023. In Group F, the team competed against rivals from Guam, Thailand, Mongolia, Hong Kong, and Malaysia, securing the 6th position among the 6 participating teams.

FIBA 3X3 Asia Cup 2022 and 2023

In a testament to its prestige, the FIBA 3x3 Asia Cup celebrated its fifth iteration in Singapore from July 6 to 10, 2022, followed by the sixth edition held from March 29 to April 2, 2023. During both of these tournaments, our esteemed BAS Men's and Women's teams showcased commendable tenacity and dedication, showcasing their skills and resilience against formidable adversaries on the global platform.

A noteworthy highlight emerged as our 3x3 Men's Team achieved a significant feat by securing a coveted place in the Quarter-finals, adding an illustrious chapter to their journey.

In the context of the FIBA 3x3 Asia Cup 2022, our Men's team secured an impressive position, ranking 9th out of the 30 competing teams. Meanwhile, our Women's team showcased their prowess by achieving a commendable standing of 12th out of the 23 participating teams.

Stepping into the FIBA 3x3 Asia Cup 2023, our Men's team continued to demonstrate their mettle, secures the 8th position among the 24 participating teams. Similarly, our Women's team maintained their competitive spirit and secured the 10th position out of the 18 participating teams, highlighting their consistent dedication to the sport

FIBA 3X3 U17 Asia Cup 2022

BAS remains steadfast in its commitment to nurturing and advancing the growth of promising young talents within the nation through its dedicated national age group development initiatives. These structured programs are seamlessly integrated into the broader national youth preparation framework, thereby serving as pivotal feeder pathways for the comprehensive men's and women's national team programs.

In the recent engagement, our U17 boys exhibited commendable performance by securing victory in 2 out of the 3 games they participated in, ultimately attaining the 14th position among the 18 participating nations. Conversely, our U17 girls delivered an exceptional display by clinching victory in 5 out of the 6 matches they contested. This remarkable feat not only led them to the quarter-finals but also secured them the impressive 6th position out of the 17 participating countries, underscoring their skill and determination on the international stage.

4. Coaching and Development

Coach Education

The Coaching and Development (C&D) Committee successfully conducted two instances of the SG-Coach Level 1 Integrated Course, spanning from 25 May to 16 July 2022 and from 14 October to 20 November. These courses garnered a total enrolment of 56 participants, with 47 individuals achieving successful completion and passing the course requirements.

Coach Clinics

Between April 2022 and March 2023, the Coaching and Development committee orchestrated a sequence of coaching clinics in cooperation with diverse partners. One of these notable clinics was the 3x3 Coaching clinic held on 11 July, featuring insights from Team China's 3x3 Head Coach. A total of 43 coaches derived benefits from this event.

On 31 October, a clinic was conducted with BAS Medical Advisor, Dr. Teoh. Of special significance was the Sports Performance Specialist Level 1 course, a substantial collaborative venture between BAS and FIBA Asia. The primary objective of this course was to elevate the basketball ecosystem by furnishing participants with a specialized strength and conditioning regimen tailored to meet basketball's unique demands. A total of 51 participants were in attendance.

NBA Basketball Without Borders (BWB) Asia 2022

Ms. Kayla Lim and Mr. Chin Zhengyu, both hailing from Singapore, were chosen by the National Basketball Association (NBA) to partake in the yearly event hosted in Canberra, Australia, taking place from the 7th to the 10th of August.

5. Technical Officials

With an impressive count exceeding 248, the Technical Committee boasts a substantial roster of registered Technical Officials (TO), encompassing roles such as Technical Commissioners, Referees, Table Officials, and Statisticians. This remarkable assembly is a testament to the dedication and breadth of expertise present within the committee's ranks.

The collaboration between FIBA and BAS stands as an ongoing and robust partnership, diligently focused on enhancing both the caliber and quantity of Singapore's pool of Technical Officials. This collaborative synergy underscores a shared commitment to nurturing and upholding the highest standards within the realm of basketball officiating.

Furthermore, our esteemed referees have exemplified Singapore's prowess on the international stage, assuming significant responsibilities that extend beyond the confines of South East Asia. Their commendable representation stands as a testament to their competence and the esteemed recognition they command on a global scale.

FIBA Game Officials' Licensing (GOL) 2023-2025

In a significant development, FIBA has designated the Basketball Association of Singapore (BAS) with a total of six (6) positions for FIBA Referees, in addition to two (2) slots for FIBA Commissioners, as part of the FIBA GOL 2023-2025 initiative. Notably, within this allocation, a specific emphasis is placed on promoting gender inclusivity, with two of the slots reserved for deserving female candidates.

In order to qualify for consideration, all nominated candidates underwent a stringent evaluation process that involved successfully completing the requisite examination conducted by FIBA. Furthermore, the candidates submitted their recorded performances for review by FIBA, underscoring the thoroughness and rigor associated with the selection procedure.

6. Tournament

In alignment with the overarching vision and mission of the Basketball Association of Singapore (BAS) to foster the growth of basketball as the preferred team sport, the Tournament Committee (TC) has strategically outlined plans to organize significant tournaments spanning various age categories throughout the current Financial Year. These prominent basketball tournaments encompass:

- BAS 3x3 Open 2022 – Men's and Women : Dates: April 12th to 14th, and April 23rd to 24th, 2022
- BAS Youth Basketball Championship 2022: Dates: June 1st to June 25th, 2022
- BAS National Basketball League Division I 2022: Dates: August 24th to September 23rd, 2022
- BAS Women National Basketball League 2022: Dates: October 5th to November 27th, 2022
- SEA Women Basketball League (SWBL): Dates: March 3rd to March 5th, 2023

These carefully curated tournaments serve as strategic pillars in BAS's endeavor to promote and advance the sport of basketball across diverse segments of the population, fostering a thriving and competitive basketball ecosystem within the country.

7. Marketing & Publicity

Launch of new BAS Logo

The silhouette depicted in the graphic encapsulates the fluid motion and self-assuredness exhibited by individuals on the court, encapsulating both movement and confidence.

Beyond its visual significance, the logo stands as a representation of BAS's overarching objective to elevate basketball into a realm of competitive excellence while also championing the ideals of equality within the sport.

The momentous unveiling of this emblem took place during the National Basketball League Final, with Mr. Eric Chua, Senior Parliamentary Secretary for Culture, Community and Youth of Singapore taking the honor. Since its unveiling on October 1st, 2022, the logo has been embraced as a symbol that encapsulates the renewed spirit and vision of basketball under the aegis of BAS.

The Marketing & Publicity Committee (M&P) persists in its dedicated pursuit of primary goals, characterized by its proactive strategy to enhance digital involvement in basketball, aligning seamlessly with BAS's overarching vision to establish basketball as the preferred team sport. This unwavering commitment entails persistent advancements across digital media platforms, notably the official website and various social media channels, all geared towards elevating engagement and viewership.

The current reach and engagement metrics indicate a substantial digital presence, with a noteworthy following of 12,075 on Facebook and 8,962 on Instagram. These numbers reflect the effectiveness of M&P's strategies in fostering meaningful connections and interactions within the basketball community, ultimately propelling the sport's reach and appeal to a wider audience.

Sponsorships & Revenue Streams

Diligent efforts have been exerted by BAS to expand its revenue sources and solidify the National Sports Association's (NSA) sustainability, in alignment with the Multi-Year Sports Plan (MYSP). The Marketing & Publicity team (M&P) has achieved significant progress, successfully securing the support of six sponsors encompassing both cash and product-in-kind contributions, for the current Financial Year.

Looking ahead, BAS remains poised to harness the vast possibilities afforded by digital marketing and collaborative ventures, such as live streaming. These avenues will be pivotal in steering the association towards sustained growth and viability, in consonance with the overarching objective of ensuring the NSA's continued sustainability.

8. Disciplinary Matters

The disciplinary committee conducted inquiries into two (2) separate incidents and subsequently levied sanctions on individuals implicated in these misconducts. Given the sensitive nature of the matter, the identities of the individuals subjected to suspension will not be disclosed in this report.

9. Secretariat Updates

Presently, the BAS Secretariat is composed of 4 full-time staff members, 2 part-time staff member, and 1 general worker. I would like to express my appreciation to the following individuals who were part of the secretariat team and made valuable contributions to the association before moving on: Ms. Tan Hui Shi, who served as the Marketing & Publicity Executive (joined in March 2022), Mr. Mohammad Fairus, who was a member of the High Performance team (joined in March 2022), and Mr. Leon Lee, who held the position of Pathway Senior Executive (joined in June 2022). Their dedication and endeavors have played a significant role in advancing basketball in Singapore during their tenure, and I extend my best wishes to them in their future pursuits.

The Secretariat staff will continue to collaborate closely with the Management Committee to ensure the seamless operation of the association while adhering to governance procedures in full compliance.

4. Coach Education

4.1 SG-Coach Integrated Level 1 Coaching Course

with the highest number of community votes and was rewarded with a cash prize of SGD 1000.

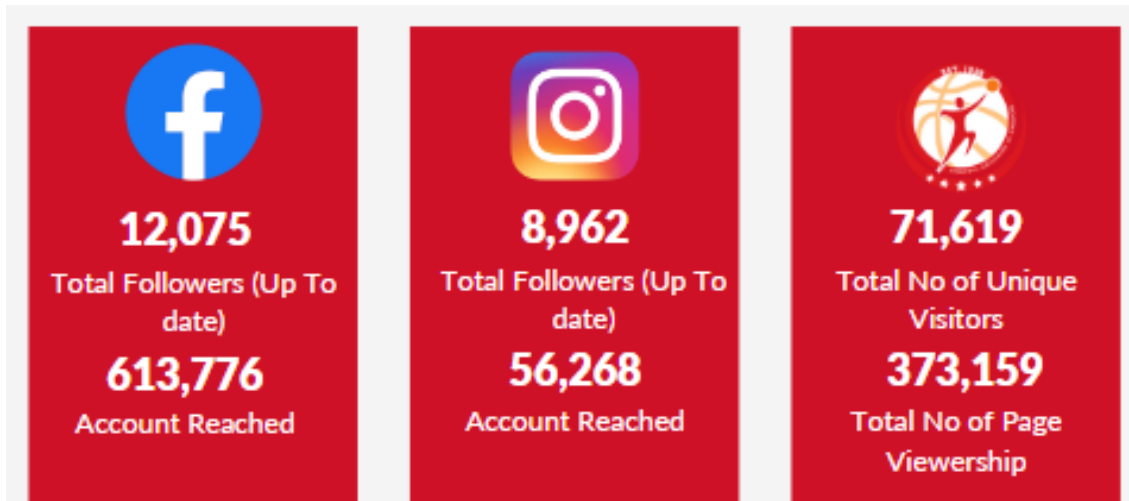
Mr Mustafa presented the meaning of the logo as per following:

Besides that, the M&P committees have developed distinctive logo designs for each of the tournaments organized by BAS. This measure aims to immortalize the BAS tournaments for posterity.



3. Digital Media Updates & Quality Content



Currently, BAS has 12,075 followers on Facebook and 8,962 followers on Instagram. In FY22, our Facebook and Instagram posts reached 613,776 accounts and 56,268 accounts respectively. As for BAS's website, we have a total number of 71,619 unique visitors and a total number for page viewership at 373,159.

The Marketing & Publicity Committee's main goal has always been to engage the basketball community and draw in more fans and the general public to the sport of basketball through regular updates about BAS events and high-quality content.

To achieve this, the M&P committee has implemented a consistent backdrop and theme for all social media posts and event/tournament updates. This standardized and modern approach is intended to capture the public's attention more effectively.

The social media updates for National Basketball League Division 1 and Women National Basketball League feature distinctive and contemporary designs when posting game results. The M&P committee has established this as a benchmark, requiring that all marketing promotions for every event must meet this standard or higher.



Besides the usual updates on the BAS event, the M&P committee also took the initiative to conduct short Q&A sessions with players and technical officials. This approach was aimed at generating public exposure and offering basic knowledge about basketball to the audience.

4. Media Coverage for Events

Besides the usual updates on the BAS events and national team status, the M&P committee also works closely with some other companies, such as local publishers, live streaming companies, and photographer studio, in order to reach out to more people and increase awareness of the sport and the organization's events. 3. COURSES & CLINICS

3.1 FIBA Asia Referee Clinic

The FIBA Asia Referee Clinic 2022 in Singapore, held from 26th to 28th April, has proven to be a remarkable triumph, drawing the participation of 33 attendees who joined the program in person, alongside around 70 participants who opted to join online. FIBA Asia Referee Clinic 2022 in Singapore was the first clinic being held in the region after a long hiatus of events due to the pandemic. The event was featured in many Sports related social media platform. The event also graced by Mr Lim Tong Hai, Referee Chairman from Football Association Singapore as part of the 2 NSA's exchange program as a sharing effort.



3.2 FIBA 3X3 Referee Clinic – Local License

The FIBA 3x3 Referee Clinic, in collaboration with SportSG, took place on 2nd and 3rd July at the Pan Pacific Hotel and OCBC Arena, and it was a tremendous success. The clinic saw a total of 30 participants and 5 observers in attendance, with Mr. Edmond Ho, FIBA 3x3 Referee Instructor and FIBA 3x3 Class A Referee, leading the course.

Over the course of two days, the clinic provided a well-rounded experience, combining theoretical lessons with practical applications to reinforce the participants' learning. This exposure allowed attendees to understand and adapt

to the international standards of 3x3 officiating practiced worldwide. Notably, we express our gratitude to Mr. Matthias Koh for gracing the event at OCBC Arena, along with Mr. Glen Chua, the Technical committee chairman.

The feedback from the participants was overwhelmingly positive, with many expressing their anticipation for similar educational sessions in the future. The credit for this successful event goes to our dedicated organizing committee.



3.3 Fitness Beep Test – Referee

On Sunday, 26th June 2022, the Fitness Beep Test, specifically designed for referees, took place at the Singapore Basketball Centre. The test saw the enthusiastic participation of 20 individuals.



3.4 Statistician Course, Clinic for IOT and 3PO and Psychology of Officiating by SportSG (NBL Div 1 preparation)

Ms. Tan Yee Nee successfully conducted the Statistician course on 20th August 2022 at the BAS conference room. The course attracted a total of 20 local referees who eagerly participated, offering them an opportunity to officiate NBL Division 1 games.



In August 2022, technical officials organized an internal clinic covering Individual Officiating Techniques (IOT) and 3-person-officiating (3PO). Additionally, they collaborated with SportSG to coordinate a session on the Psychology of Officiating, specifically aimed at preparing for NBL Division 1 officiating duties. It is the first time ever that BAS has organized such a class for Technical officials.

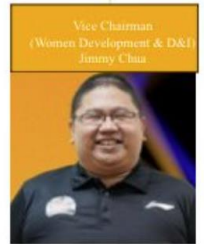
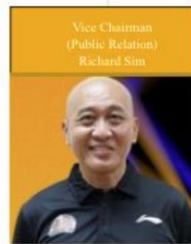
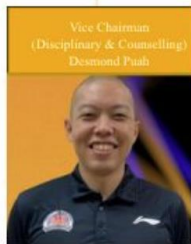
