#### IMPORTANT NOTES:

- (a) Each candidate must **submit a copy of their CV and a completed Candidate Profile Form (Annex C)**, which will be published on the BAS website before the election. In line with PDPA, only the Annex C form will be published and it will then be removed after the election.
- (b) Pursuant to the Constitution Article 19.2, the candidate nomination forms are prescribed by BAS, and BAS may further reject incomplete forms, improperly completed forms, or illegible forms.
- (c) Rectification/amendments to the submitted form may be allowed, BUT **the identity of the election candidate strictly cannot be amended**. This is because, pursuant to the Constitution Article 19.7, the list of eligible candidates has to be published at least 5 days in advance before the election. And pursuant to the Constitution Article 19.3, a nomination only requires a Full Member to propose and another Full Member to second.
- (d) \*\* Pursuant to Constitution Article 19.6, the independent election panel (2 or more independent members from the Board) is responsible for verifying and confirming the voting eligibility of Full Members, their Authorized Delegates, and the nominated candidates, for the Board election. The independent election panel therefore has the power to verify and conduct the necessary checks – this will include being satisfied of the legitimacy of any election nomination form submitted.
